- May 24 - JFC wrote a letter and published a statement supporting the ratification of the Freedom of Access to Information Bill. The bill will provide a clear, uniform and speedy procedure for access to information of public interest in the possession of any government agency.

The JFC is also currently working on the publication of Roadmap 2010 that will be a summary and review of in depth focus group discussions held in a number of key sectors. This Roadmap will be working document and be presented to the new administration.
