## **Did you Know?**

Filipinos in Canada

There are currently 554,000 Filipinos living permanently in Canada. This number jumps to 640,000 when you add those working temporarily and those who are part of the irregular migration

For the period 1981-2010, the top countries of destination for Filipinos migrating permanently were the USA (1,165,352), Canada (284,663), Japan (116,748) and Australia (109,668).

In 1981, a total of 40,307 Filipinos migrated to the USA while 5,226 went to Canada. By 2011 this number had remained fairly static for those going to the USA with 42,007 migrants selecting that country as their new home while the number going to Canada had increased significantly to 27,302. An increase of 522%!!

In 2010, for the first time, the Philippines became the number one source country for immigrants going permanently to Canada.
